

# Durham Champions Cricket Club's Liability Waiver

This Liability Waiver and Release of Claims (the "Waiver") is made by and between [Durham Champions Cricket] (the "Club") and the undersigned participant (the "Participant").

1. Assumption of Risk: By participating in cricket activities, events, practices, games, leagues or any other related activities organized by the Club, the Participant acknowledges and understands that there are inherent risks associated with the sport of cricket, including but not limited to, physical injury, property damage, or other accidents. The Participant voluntarily assumes all risks involved in participation.

2. Release of Liability: The Participant hereby releases, waives, and discharges the Club, its admin staff, coaches, staff, volunteers, sponsors and agents from any and all liability for injuries, losses, or damages, whether caused by negligence or otherwise, arising from participation in cricket activities or related events organized by the Club.

3. Medical Treatment: In the event of an emergency, the Participant authorizes the Club to seek medical treatment or emergency services on their behalf if necessary. The Participant agrees to bear the costs associated with such medical treatment.

4. Indemnification: The Participant agrees to indemnify and hold harmless the Club, its admin staff, coaches, staff, volunteers, and agents from any claims, losses, damages, or expenses arising from the Participant's actions, including but not limited to, negligence or misconduct, misbehave during participation in cricket activities.

5. Code of Conduct: The Participant agrees to adhere to the rules, policies, and code of conduct set by the Club. The Participant understands that any violation of these rules may result in suspension or termination from participation in Club activities.

6. Governing Law: This Waiver shall be governed by and construed in accordance with the laws of [Pickering/Ajax/Whitby/Oshawa/Ontario/Canada], and any disputes arising from this Waiver will be resolved in the appropriate court in that jurisdiction.

7. Acknowledgment: By signing this Waiver, the Participant acknowledges that they have read and fully understood the contents of this document, and they voluntarily agree to its terms.

8. Minor Participants: If the Participant is under the age of 18, this Waiver must be signed by a parent or legal guardian. The parent or guardian assumes all responsibilities and liabilities for the minor's participation.

# Privacy Agreement:

At Durham Champions Cricket Club, we are committed to protecting your privacy and ensuring that your personal information is handled in a safe and responsible manner. This Privacy Agreement outlines how we collect, use, and safeguard your information in accordance with applicable privacy laws.

## 1. Information We Collect:

We may collect the following types of personal information from members and participants:

Contact Information: Name, email address, phone number, and mailing address.

Demographic Information: Age, gender, date of birth, and other details necessary for membership and participation.

Health and Fitness Information: Medical history, injury records, and other relevant health details for safety and welfare purposes.

Payment Information: Details related to membership fees, event costs, or donations.

Activity Data: Performance statistics, attendance records, photos, pictures and participation in club events and membership process.

## 2. How We Use Your Information:

We use your personal information for the following purposes:

To communicate with you regarding club activities, events, training schedules, and other updates.

To process membership registrations, payments, and other related administrative tasks.

To manage player's health and fitness, including injury tracking and emergency contact information.

To improve club services, including games & leagues organizing, coaching, training, and event planning.

To comply with legal or regulatory requirements where applicable.

## 3. Data Sharing and Disclosure:

We will not share your personal information with third parties without your consent, except in the following circumstances:

Service Providers: We may share your information with trusted third-party service providers who assist us in conducting club operations (e.g., payment processors, event organizers, Cities and Towns of Durham region, club sponsors etc.), but they will only have access to the information necessary to perform their tasks.

Legal Compliance: If required by law or to comply with legal processes, we may disclose your personal information to relevant authorities.

Emergencies: In case of an emergency, we may share relevant medical or contact information with emergency responders or medical professionals as necessary.

#### 4. Data Security:

We take reasonable steps to protect your personal information from unauthorized access, alteration, disclosure, or destruction. We use secure technologies and practices to safeguard your data, including encryption and access controls as much as possible, reasonable and realistic in a non-profit club/organization operations.

#### 5. Data Retention:

We retain your personal information only for as long as necessary to fulfill the purposes for which it was collected, or as required by law. Once your data is no longer needed, we will securely dispose of or anonymize it.

#### 6. Your Rights:

You have the right to:

Access the personal information we hold about you.

Request corrections to any inaccurate or incomplete information.

Request the deletion of your personal information, subject to any legal or contractual obligations.

Withdraw your consent at any time, where applicable, by contacting any club admins.

#### 7. Changes to This Privacy Agreement:

We may update this Privacy Agreement from time to time. Any changes will be posted on our website and communicated to you through the appropriate channels. Please review this agreement periodically to stay informed about how we are protecting your privacy.
